



Requirements for the abstracts and papers:

Abstracts should be 1 or 2 A4 pages long and research articles can be up to 5 A4 pages. Margins from all sides should equal 2.5 cm. The recommended text editor is Microsoft Office Word, and Times New Roman font with a size of 12 pt and interval of 1.0 should be used for the main text. Pictures, graphs, and diagrams must be in *.png or *.jpeg format.

An example of the abstract and article structure:

File names sent via email should include first author's surname followed by the portion of the title (3-5 words). Example of a file name: Rozykov_Province_cleaning_effect.docx

Together with the abstract, the following information about the conference participants should be shared with the organizing committee:

- 2. Position and affiliation
- 3. Academic degree and title
- 4. Title of the presentation
- 5. Participation mode (online or offline)
- 6. Phone number (optional)
- 7. E-mail
- 8. Conference session chosen for your presentation.

Note: The organizing committee reserves the right not to consider materials that do not meet the specified requirements.

The abstracts and papers should be original and not previously published or presented at other conferences. The abstracts should provide a brief summary of the research objectives, methods, results, and conclusions, while the papers should provide a detailed description of the research, including the background, methodology, results, discussion, and conclusions. We believe that the conference will be a great opportunity for scientists, researchers, and students to present their latest findings, exchange ideas, and discuss recent developments in the field of geology and environmental sciences. The conference will feature keynote speakers, plenary sessions, and parallel sessions covering various topics related to geology, such as mineralogy, petrology, geophysics, geochemistry, and environmental sciences, among others.
